## **Contract Terms and Conditions**

The following terms and conditions shall apply in respect of all photographic workshop bookings made through Scotland360° Photography and will form the basis of your contract with Angus Mackie.

1. This Contract is entered into by Angus Mackie of Scotland360° Photography and the Client. Scotland360° Photography's contact details are as follows:

2. This contract is accompanied by a completed "Workshop Booking Form", which shall be read in conjunction with and shall form an integral part of this Contract.

## **Fees**

3. The retainer fee and total fee payable shall be dependent upon the workshop package selected by the Client in completing the Workshop Booking Form, which details the fees payable for each booking option. The Client is required to select one of the listed packages at the time of making the booking.

4. The fee arrangements for the Low Light Photography workshop are as follows:

a. At the time of booking, the Client shall pay a retainer fee of £20, in return for which Scotland360° Photography shall reserve a place for the Client on the selected workshop. A confirmation email will be sent to the Client by Scotland360° Photography with confirmation of details. The retainer fee is non-refundable and is not transferable to any other date. The retainer fee shall constitute the first instalment of the total fee payable to Scotland360° Photography, and shall reduce the outstanding amount of the total fee owed by the Client to Scotland360° Photography accordingly.

b. Two (2) weeks before the workshop start date, the Client shall pay the outstanding amount of the total fee in full.

c. If the Client is booking within two (2) weeks of the workshop start date, full payment will be required at the time of booking.

5. If the Client does not make payment as it falls due in accordance with the terms of Clauses 3 and 4 above, Scotland360° Photography reserves the right to cancel the booking, terminate this Contract and retain the non-refundable retainer fee.

### **Cancellation by the Client**

7. Should the Client need to cancel a workshop booking, then it is their sole responsibility to do so in writing or by email. The Client must ensure that this instruction has been received by Scotland360° Photography. Scotland360° Photography will personally contact the Client to discuss the cancellation and send confirmation of the details received.

8. All reasonable efforts will be made to re-allocate any cancelled workshop places. If the Client's cancelled place is filled, then any monies paid by the Client shall be fully re-funded by Scotland360° Photography, minus the retainer fee.

9. Where a partial or full refund is to be provided by Scotland360° Photography, the total amount due shall be returned to the Client, minus the retainer fee and any fees incurred by using an online processor such as Paypal or bank transfer.

10. Workshop bookings are non-transferable between participants and/or workshops.

11. If the Client fails to arrive at the designated meeting place at the workshop start time, this will be treated as a cancellation by the Client and no refund will be provided by Scotland360° Photography.

## **Description of Services**

12. Scotland360° Photography will provide photographic tuition as outlined in the relevant workshop package. The workshop package selected is described on the price list in effect at the date this Contract is signed.

13. Scotland360° Photography reserves the right to change the workshop itinerary due to altered circumstances and conditions. Scotland360° Photography will make alternative arrangements as required but no refunds will be given for services or locations that are not utilised as a result.

## **Limitation of Liability**

14. If Scotland360° Photography is unable to operate the Client's chosen workshop due to any circumstances beyond Scotland360° Photography's reasonable control, including (without limitation) natural disasters, civil unrest, force majeure, injury, sickness or technical difficulties, all reasonable efforts will be made by Scotland360° Photography to arrange an alternative date to the reasonable satisfaction of the Client, although this cannot be guaranteed. Scotland360° Photography shall have no further liability to the Clients for any additional losses, costs or expenses incurred as a result of any inability to attend under this Clause.

15. If Scotland360° Photography is unable to operate the Client's chosen workshop due to any circumstances beyond Scotland360° Photography's reasonable control, Scotland360° Photography's liability shall be limited to a full refund of monies paid.

16. Scotland360° Photography's workshops can involve travel in remote areas where amenities and medical facilities are not readily available. All reasonable efforts will be made by Scotland360° Photography to ensure the Client's safety and well-being; however, it is a fundamental condition of booking that the Client accepts the risks and hazards involved in visiting roadside locations, remote areas and rugged terrain.

17. Due to the adventurous nature of some workshops, the Client must at all times agree to comply with the decisions taken by Angus Mackie of Scotland360° Photography.

18. It is recommended that all participants be fully insured for the duration of workshops. Participants are responsible for arranging their own insurance. It is recommended that this covers medical expenses, injury, death and repatriation. It is advisable that the Client also has cancellation and curtailment in his or her insurance policy. It is also advisable that the Client should be insured against loss or damage to baggage and personal possessions, including all photographic equipment.

19. Scotland360° Photography will not accept liability for death, bodily injury or illness incurred on the Client's chosen workshop. Furthermore, Scotland360° Photography will not



accept responsibility for lack of fitness, carelessness, negligence or lack of punctuality attributable to the Client.

20. If the Client has a disability or illness, he or she should inform Scotland360° Photography at the time of booking so that Scotland360° Photography can provide advice on the suitability of the workshop.

21. Personal items, valuables and baggage, including photographic equipment, remain the responsibility of the Client at all times. Scotland360° Photography will not accept responsibility for any loss of personal items, valuables or baggage, including photographic equipment, during the Client's chosen workshop.

22. By entering into this Contract, the Client accepts responsibility for any equipment loaned to the Client by Scotland360° Photography during the Client's chosen workshop, and the Client must pay for any loss or damage caused to this equipment whilst in his or her possession.

23. It is the Client's own responsibility to make travel arrangements to workshop starting points. Scotland360° Photography cannot take responsibility for any travel delays encountered by the Client.

24. Scotland360° Photography is unable to accept bookings from persons under eighteen (18) years of age.

## **Dispute**

25. Any complaints regarding the Client's chosen workshop should be made in writing within fourteen (14) days of the workshop end date to Scotland360° Photography, Birchmill House, Culbokie, Dingwall, Ross-shire, IV7 8JH or by email to [angus@scotland360.co.uk](mailto:angus@scotland360.co.uk). Scotland360° Photography will endeavour to respond within seven (7) days.

26. The Law of Scotland shall apply in the unlikely event of a dispute arising. If the dispute cannot be resolved directly between Scotland360° Photography and the Client within six (6) weeks of written intimation of the dispute, both Scotland360° Photography and the Client shall attempt to settle the dispute by mediation. A Mediator will be selected with the assistance of the Law Society of Scotland. If mediation is unsuccessful, the Sheriff Court in Inverness shall have jurisdiction.

## **Privacy**

27. Scotland360° Photography will store the Client's details on a private internal database. These details will not be made available to companies or individuals outwith Scotland360° Photography.

## **Digital Agreement**

28. By completing this online form, the Client hereby agrees to enter into a contract with Scotland360° Photography as detailed above. Any person making a workshop booking on behalf of others accepts that all persons covered by the booking are bound by this Contract and terms and conditions. This Contract is subject to normal terms and conditions as a written contract would be.
